FREEMASONRY IN WEST YORKSHIRE.

There is, invariably, some interesting or instructive information to be gleaned from the reports of the different Provincial gatherings in West Yorkshire, and that of the recent half-yearly meeting of the Prov. Grand Lodge at Bradford is no exception to the rule. The presiding officer—who on this occasion was Bro. RICHARD WILSON, P.G.D., the respected Dep. P.G.M. always has a something to lay before the brethren, be it in the nature of an exhortation to greater efforts on their part to strengthen the Craft in this or that direction, or to some special effort in order to meet some pressing emergency. Or, if the meeting takes place in a city or town, which is recognised as one of the great strongholds of Freemasonry-and several such places are to be found in this Province—it may suit his purpose better to dilate on the services of former generations of Craftsmen, with the idea of stimulating the present to emulate their work, or, as in this case, of commending them for the continued excellence of their service. At Bradford, as may well be imagined, there was no lack of material that would satisfy all and every of these conditions, and a mere glance at Bro. Wilson's address will serve to show that he undoubtedly made the most of his opportunities. But, in addition, there devolved upon him the very agreeable duty of presenting a most worthy officer of the Prov. Grand Lodge with a token of the respect in which he is held by the brethren of the Province, and in recognition of the many and valuable services he has rendered during a long term of years. Bro. Major HERBERT GREEN is one of the most prominent figures in West Yorkshire Masonry. As Prov. G. Secretary he has been long known far and wide, not only among those with whom he is officially connected, but likewise among the whole body of English Craftsmen, who cannot be otherwise than familiar with the name of a leading executive officer of so strong a Province, and the manner in which he has performed his duties. Thus no surprise was felt when it became known that, on the occasion of his installation as M.W. Grand Master his Royal Higness the Duke of CONNAUGHT had included Bro. Green among the brethren on whom he was pleased to confer brevet rank as Past Grand Officers of England. Everyone realised that Bro. Green was worthy of the distinction conferred upon him, and at Bradford his West Yorkshire brethren went still further, and by way of showing their sense of the honour done to one of their most trusted and experienced officers, presented him with the clothing of his rank as Past Grand Officer in Craft and Royal Arch Masonry. We congratulate Bro. GREEN on being the recipient

of such a testimonial, more especially as all the lodges in the Province took part in the subscription.

The report of the Charity Committee of the Province was presented by the Vice-Chairman (Bro. H. S. CHILDE) in the absence through illness of the Chairman (Bro. BLACKBURN), and, as usual, the Committee had the satisfaction of announcing that their efforts during the past six months in behalf of the candidates for the Schools, had been successful. Bro. Childe, however, took the opportunity of impressing upon the brethren that the task which awaited the Committee in respect of the School and Benevolent elections in April and May of next year was the hardest they had as yet had to cope with, and he trusted the members would spare no efforts to enable them to secure the success of the West Yorkshire candidates.

One other subject engaged the attention of the meeting but no decision was possible under the circumstances. At the previous meeting of Provincial Grand Lodge at Dewsbury, Bro. J. T. LAST, P.M., P. Prov. G. Reg., gave notice of his intention to move certain resolutions relating to the mode now in force of electing the Grand Treasurer of United Grand Lodge. Unfortunately, he omitted to comply with one of the Bye-laws of Provincial Grand Lodge requiring that 14 days' notice should be given of the terms of the resolution. There is no doubt that a change in the mode of election to this office is desirable, that is, if Grand Lodge wishes to free itself from the turmoil and March Communications, excitement which attend the whenever two or more brethren offer themselves as candidates for the office, and there is the likelihood of a severe contest. The plan which Bro. LAST appears to favour is to substitute proxy for personal voting, and thereby save brethren-and more especially those living in the more distant Provinces-the expense and inconvenience of attending Grand Lodge and personally recording their votes, This would entail a very serious amount of additional labour on the part of the Grand Secretary and his staff, and a considerable outlay on the part of It would cost a goodly sum to send out voting Grand Lodge. papers to the 30,000 brethren, who, as Masters, Wardens, and Past Masters, have the entrée to Grand Lodge, and are entitled to take part in its proceedings, and Grand Lodge-to use a familiar expression-might not think the game worth the candle. But the question is one which cannot be discussed offhand, and, as Bro. LAST'S resolutions cannot be submitted to the Provincial Grand Lodge of W. Yorkshire for the next six months, we feel inclined to wait in the hope and belief that in the multitude of counsellors there will be found the usual amount of wisdom,

THE FIELD LANE INSTITUTION.

This Institution—which is better known as the Field Lane Refuges and Ragged Schools—was founded in the year 1841, and, considering the difficulties that it has had to contend with, and the vast amount of energy and resources that have had to be displayed, it seems simply wonderful that it should be in the position it is at the present moment.

Now, a word as to the work done by the Institution. It comprises Refuges, Crêche, Mothers' Meetings, Ragged Church Services, &c., and certainly one of the greatest of these, and which appeals very strongly to us—is the Crêche. What a blessing it is to a poor woman, who has one or two young children, to be able to go out to do her day's labours and to feel confident that her little ones are safe and in good hands. Labouring, as the Society does, in the heart of one of the very poorest

districts of London, the amount of relief it affords to these poor people is very remarkable. Every day food is distributed, which comprises the broken and other food left over by the employes of certain City firms, and is collected daily. Again, there are the Mothers' Meetings held weekly, and which are very popular, The Boys' and Girls' Certified Homes, and attended largely. which are situated at Hampstead, Girls' Sewing Classes, Youths' Institute, &c., all of which are energetically attended, and

worked by the Institution. We will now look to the financial side of the question. At the last annual meeting it was shown that the expenditure over the income was £509, and that the Institution was in debt to their bankers to the extent of £1000. This should not be, and we would earnestly appeal to our readers to generously meet their urgent efforts in reducing the amount, and placing them in the position they should be, viz., free of debt. Such an Institution as this cannot fail to strike one of the earnest endeavours to meet the continued strain put upon it by the increased applications of the poor people of the district in which it labours, and we do not think we are appealing in vain in doing so.

CONSECRATION OF THE BRIDGE TRUST LODGE, No. 2878.

The consecration of the above lodge took place on Wednesday, the 13th instant, at the Grammar School, Grove-lane, Handsworth. and influential muster of brethren, especially of Installed Masters and Wardens, to do honour to the occasion, and to support the Earl of Dartmouth, Prov. Grand Mastership of Lord Dartmouth, who was installed in 1894, at Wolverhampton, by the late Right Hon. the Earl of Lathom, M.W. Po G.M., in the verhampton, by the late Right Hon. the Earl of Lathom, M.W. Pro G.M., in the presence of the largest gathering of Freemasons that has ever taken place in Staffordshire. The name—Bridge Trust—is a peculiar but popular one, the idea being to form a lodge in connection with a foundation round which cling many cherished memories bearing the name of a Charity, the origin of which is lost in obscurity and may, therefore, with but little stretch of imagination be claimed as from "Time Immemorial." In the long ago a gentleman in Handsworth left "certain messuages, land, and hereditaments, the rents and profits of which were to be employed towards the repairing and maintaining of bridges within the parish as need should require; and, if it should happen that there should be any overplus of the rent, then the same should be employed and bestowed on some good and charitable uses within the parish of Handsworth." In later years, owing to change I conditions, the Trust money accumulated, and through the Charity Commissioners the Fund was devoted to purposes of education in Handsworth and the School, at first called Bridge Trust, is now the Handsworth Handsworth and the School, at first called Bridge Trust, is now the Handsworth Grammar School.

Grand Secretary read the warrant or charter of constitution from the Grand Master, II.R.H. the Duke of Connaught, K.G. The warrant was dated October 3rd, 1901. The brethren having tormally signified their approval of the officers named in the warrant,

The Prov. Grand Charlain delivered the following oration on the nature and principles of Masonry:

Masonry is of such a nature as to appeal not only to a man's inherent desire for the society of his fellows, but in a higher and more worthy sense it also appeals to his reasoning faculty, and through that to his intellect. Masonry is a progressive science, and requires the exercise of the intellectual faculty in order to adequately discover the manifold treasures which underlie the grand principles accquately discover the manifold treasures which underlie the grand principles of our noble Institution, therefore progress in Masonry is attained not by completing a certain period of membership, but by making a daily study of its secret arts and hidden mysteries. Ever learning that we may know, ever searching that we may find, ever pursuing that we may advance. Every candidate for initiation is solemnly informed that there is nothing in the nature of Masonry incompatible with his religion. As this undeniable assertion is made before admission into the Order, it necessarily implies that the vows of fidelity which he is about to take coincide and are consistent with the religious belief he already holds, so that it is only reasonable not sistent with the religious belief he already holds, so that it is only reasonable not sistent with the religious belief he already holds, so that it is only reasonable not merely to infer, but emphatically state, that it was never intended that the Masonic system should supersede but supplement our faith. By studying and acting up to the "natura" of Masonry, we shall attain closer union with the "persona" of our Divine Architect, and by our secret arts and hidden mysteries we shall the better be enabled to unfold the beauties of true godliness. The religion of Masonry is a priceless help in building up the life in God, but the religion of God must not be lost or forgotten in Masonry. The lesser must not be a substitute for the greater; but the greater should embrace and permeate the lesser. This, I take it, is the light in which the nature of our Masonic Order should be viewed and considered. With regard to the purposes of Masonry, they are legion. They embrace everything which tends to make a Mason a man worthy of the Greator's love, a shining light in his family circle, an example of considerateness and straight dealing in light in his family circle, an example of considerateness and straight dealing in his commercial avocation, an acceptable addition to any body or society to which he may belong, and a friend to the distressed. These and other kindred virtues are to be acquired by carrying out the purposes of Masonic life. And it is gratifying to realise that there is a further demand for the addition of a new lodge through the medium of which our noble principles and tenets may be infused into the lives of the already existing brotherhood formed in school days. We have met to-day to take part and share in the joy of erecting and consecrating this lodge to the honour and glory of the Great Architect of the Universe, and under the title of "Bridge Trust." May you, my brethren, who are now to be appointed as officers and members continue to act and abide by the ancient usages and customs of the Order! May the Divine blessing ever rest on you, your lodge, ard all who in the future may be added to your members! In carrying out the purposes of Masonry, may the world, the Craft in general, and this Bridge Trust Lodge in particular, be all the better; nobler, and the more godly by your membership! May you flourish and prosper, and leave behind you a name, and influence for good, and thus prove to the world the blessing of Masonry! odge through the medium of which our noble principles and tenets may be Masonry!

Masonic Motes.

We have much pleasure in announcing that his Majesty the King has been graciously pleased to accept the position of Patron of the Household Brigade and Navy Lodges, Nos. 2614 and 2612 respectively. It will be in the recollection of our readers that his Majesty, until his accession to the throne, was permanently Master of these lodges, so that the tie that binds him to them still exists but under another name.

We must not omit to mention that among the brethren of distinction who have passed away recently but few have done greater service to Freemasonry than Bro. Harry Nelson Price, P.M., P.Z., Past G. Std. Bearer England, who had not only presided both in lodge and chapter, but had also been an enthusiastic supporter of our Institutions. Bro. Price died at Hythe on Tuesday, the 29th October, and was buried on Friday, the 1st instant, a large number of his brethren being among those who were present at the graveside.

We have received Volume XIV., Part 2, of "Ars Quatuor Coronatorum," and shall take the earliest available opportunity of acticing at length and in detail the contents of this always welcome publication. In the m antime, however, it may be as well to draw

bore the old familiar inscription: " Edited for the Committee by Bro. G. W. Speth, P.A.G.D.C., Sec.," while the Part 2 we have just received bears the same inscription but with the name of "W. H. Rylands, P.A.G. D.C.," substituted for that of Bro. Speth, who is thus succeeded in his dual office of Editor of these Transactions and Secretary of the lodge by one of his oldest friends and ablest fellow-labourers in the field of Masonic literature. The loss which Lodge Quatuor Coronati has sustained by the lamented death of Bro. Speth is, indeed, a serious one, but the members will find consolation in the knowledge which the issue of this second part of their Transactions for the current year will bring home to them very forcibly-that Bro. Speth's mantle could not have fallen on worthier shoulders than on those of our respected Bro. Rylands.

It may also be well to mention that the new Part is likely to prove doubly acceptable to the members of both circles, by reason of the fact that it contains life. like presentments of (1) the late Bro. Speth, and (2) the late Bro. Sir Walter Besant, who were both founders of the lodge, and until the days of their respective deaths were in Bro. Speth's case the first and only Scoretary, and in Bro. Besant's, the first and only Treasurer Lodge Quatuor Coronati had known, and who passed hence within a few weeks of each other. Both portraits are excellent, but that of Bro. Speth is a particularly happy one, presenting him to the reader, as it does, in the character we must all of us most naturally desire to associate with him, as one of the truest, kindest, and most genial of men and Masons. Both these portraits are beautifully printed, while those who desire to know something of what the men themselves were, will find the leading facts in their respective careers carefully and lovingly set forth in the accompanying memorial sketches compiled by Bro. Rylands.

We have also received copy of the work on "British Masonic Medals" which has been compiled by Bro. G. L. Shackles, and the value of which is very materially enhanced by an admirable introduction from the pen of Bro. Dr. W. J. Chetwode Crawley. The volume contains 12 plates of engravings from photographs taken for it from the best known extant specimens of the medals themselves, and these are accompanied by full letter press descriptions of 115 specimens. We shall take the earliest available opportunity of reviewing this important book.

'We have already in one of our preceding Notes referred to Bro. W. H. Rylands as the successor of Bro. G. W. Speth as Secretary of Lodge No. 2076, and from the report we published last week of the installation meeting of the lodge on the 8th instant, it will be seen that the office of Treasurer, rendered vacant by the death of Bro. Sir W. Besant, has been filled by the election of Bro. Hamon Le Strange, Prov. G. Master of Norfolk, who has already made for himself a name in the annals of Masonic literature as author of a most interesting History of Freemasonry in the Province over which he so worthily presides. It will also be seen that a resolution of sympathy with Mrs. Kupferschmidt, in the loss she has recently sustained by the death of her husband, who was a P.M. of the lodge, as well as Assistant G. Secretary for German Correspondence.

In acknowledging the Grand Lodge and Grand Chapter clothing recently presented to him, Bro. Major Herbert Green, Prov. G. Secretary of West Yorkshire, furnished an array of interesting statistics which testify unmistakably not only to the progress which that Province has made during the last 16 years, but also to the immense amount of useful work it is constantly doing. During this period there have been 4792 initiations or joinings, 1955 resignations, 1121 deaths, 775 exclusions, the number of entries in the Provincial Register hereby rendered necessary being 8643. The presented number of subscribing members is 4339; so that in the course of these years there has been a complete change of membership. Again, during the same period there has been contributed to the Central Masonic Charities upwards of £75,000, and this is irrespective of other sums raised towards testimonials and for other purposes, the bulk of this money having passed through Bro. Green's hands.

Then as regards the election of candidates to these Central Charities, West Yorkshire has carried successfully 188 cases, the number of votes which have been collected and manipulated in securing their election being 457,000. These figures, which attention to the fact that the cover of Vol. XIV., Part 1, almost take one's breath away, show that the office

which Bro. Green has occupied so honourably to himself and with such advantage to his Province is about as far removed as possible from being a sinecure, and we cordially echo the wish so fervently expressed by the acting Prov. Grand Master when making the presentation that many many years may pass ere he will find himself under the necessity of appointing a successor to our able and distinguished brother.

At p. 355 of Bro. John Armstrong's "History of Freemasonry in Cheshire," we read that on "October 15th, 1851.—Bro. Dixon, P.M., proposed Mr. Horatio Lloyd, 22, Student-in-Law, of the City of Chester, a candidate for Masonry," and, further, that "Bro. Lloyd was initiated December 10th, 1851, and became W.M. in 1854, Recorder of Chester in 1866, Judge of the County Court 1875, and was Knighted in 1890." The lodge in which the Masonic circumstances here recorded took place was the present Cestrian Lodge, No. 425, and the brother whose introduction into Masonry, and subsequent election to the chair of K.S. in his mother lodge, is thus briefly recorded, is the present Bro. his Honour Sir Horatio Lloyd, P.G.D. of England, Dep. Prov. G.M. Cheshire; and Past G.S.B. England, and P.P.G.H. in the Royal Arch. In his Prov. Grand Lodge our respected brother has served as S.G.D. (1856-8), S.G.W. (in 1874 and 1875), and as Deputy P.G.M. since 1887. He was appointed to Grand rank in 1879, and has played a leading part in Cheshire Masonry during the greater part of the period in which he has been connected with the Craft.

On the 10th December, Bro. Sir Horatio Lloyd will celebrate the Jubilee of his acceptance into the Order in the Cestrian Lodge, and it is the intention of his Cheshire brethren to mark the auspicious event by presenting him with a service of plate in recognition of the signal service he has rendered to their Province and in token of the respect and esteem they entertain for him personally. During his long career, he has done a vast amount of good serviceable work not only in his own particular Province of Cheshire, but likewise generally, and it is as honourable to our Cheshire brethren that they should thus recognise the benefits they have derived from his work as it is to Bro. Sir H. Lloyd that he should be the recipient of this distinction.

We congratulate Bro. the Hon. James Hozier, M.P., on his re-election for the third time to the chair of the Grand Lodge of Scotland. Bro. Hozier has discharged the duties of his high and responsible office in a manner that has secured to him the respect of the whole Scottish Craft, and is in every respect worthy of the honour which Grand Lodge has done him by choosing him as their ruler for a further period. An illustration of the tactful manner in which he acts was furnished on this occasion, when, on a note of opposition being sounded to the acceptance of Grand Committee's recommendation re the Denmark-Hamburg dispute, the Grand Master pointed out that a refusal on the part of Grand Lodge to uphold the Grand Committee would be tantamount to a denial to the Grand Lodge of Denmark's sovereignty within its own territory.

As regards the Grand Committee's recommendation to the effect that the recognition of the Grand Lodge of Western Australia was premature under the circumstances, we consider there was fair justification for the course pursued by Grand Lodge in adopting it. Of the 28 lodges under the Scottish Constitution in the Colony as many as 26 have expressed a desire to retain their connection with the present Grand Lodge, so that there is no such transfer of allegiance as would justify any other than the course proposed by the Grand Committee. What may come to pass in the future, when the local Grand Lodge, at present composed for the most part of lodges originally constituted by the Grand Lodge of England, is in a position to exercise a greater influence, cannot be foreseen. It is enough for us that, in our opinion, the Grand Lodge has taken the right course, and in such a manner as to permit of its changing its policy hereafter should the necessity arise.

It is greatly to be regretted that Bro. James Berry has found it incumbent on him, owing to the state of his health, to resign the office of Prov. Grand Master of Forfarshire, which he has held with great distinction for some years past, but a most worthy and able successor has been found in Bro. the Hon. Charles M. Ramsay, more than one member of whose family has held the same office in the past with the greatest advantage to the Province.

The Field Lane Ragged Schools and Refuges, with which I have had the honour of being associated for 16 years, are at the present time urgently in need of special public aid to enable them to continue their beneficent

The Institution celebrates this year its Diamond Jubilee, having been permitted for 60 years to carry on its work.

That work embraces the religious instruction of some of the poorest children in London; the training of waifs and strays in the certified Industrial Schools, in which they are fed, clothed, educated, and technically instructed; and the nurturing of infants and young children in the Crêche.

It also carries on a strenuous contest against intemperance by means of the Gospel Temperance Society; endeavours to inculcate principles of sobriety through the Band of Hope; and encourages thrift by means of its various Clubs and Savings Banks.

Another part of its functions is the maintaining of Refuges for persons of respectable character who have sunk into the most painful want; and the conducting of Mission Services, which are attended by a large number of the poor of the immediate neighbourhood and by hundreds of outcast and homeless.

The institution, in common with many others, has suffered severely during the past few years through the many demands that have been made on public charity, and is, consequently, unable, in spite of the most rigid economy, to meet, with its present average receipts, its necessary expenses.

Society can ill afford, when so many pernicious influences are at work, to dispense with an agency for good such as this; and yet there is a great danger that some portion of the work may have to be given up unless it receives imme-

I trust this may be averted, and that public liberality will kindly respond to an appeal on behalf of an undertaking which is well deserving of sympathy and
